RE: ESTABLISH INSTALLMENT PAYMENT PLAN FINANCING CURB BOX/SERVICE CONNECTION ASSESSMENTS FOR PROPERTY OWNERS BENEFITED BY THE BLUEPRINT WATERLINE INITIATIVE COUNTY PROJECT NO. 5-W-15

MOTION: Made by Mr. Polivka, seconded by Mr. Fuda, to establish an installment 6. payment plan for the purpose of financing CURB BOX/SERVICE CONNECTION ASSESSMENTS for property owners that were benefited by the BLUEPRINT WATERLINE INITIATIVE PROJECT, known as County Project No. 5-W-15. Installment payments are to be certified by the Trumbull County Auditor and placed upon the real property tax list and duplicate against the property served by the connection—identified by parcel number. Upon collection of the installment payments, the funds are to be transferred to the Braceville Township Water District Fund No. 612-000-3000-3030-1-407000. The curb box/service connection assessment is \$650.00 per curb box. The installment plan will be at the same terms as the Ohio Water Development Authority (OWDA) loan that was used to partially finance the project which includes a fixed zero percent (0%) annual percentage rate (APR) for thirty (30) years. This will result in an annual payment of \$21.67/year plus a statutory three percent (3%) Auditor/Treasurer Collection Fee. The affected property owners have been given the option to pay the curb box/service connection assessment either partially or in its entirety in lieu of paying in installments; this action per the recommendation of the Trumbull County Sanitary Engineers Department and is subject to review and approval of the Prosecutor's Office.

NOTE: Per requirements of the Ohio Revised Code, proper notification was given to each affected property owner as part of the Necessity Resolution passed by the Board of Trumbull County Commissioners on February 28, 2018, duly recorded in Journal Volume 147, Page 21453.

(Costs will be paid by the Trumbull County Engineer prior to submittal for reimbursement by a 75% grant through the Ohio Department of Public Safety). Lakeview Drive was closed on July 20, 2019 due to damage caused by severe flooding; this action per the recommendation of the Trumbull County Engineer and is subject to review and approval of the Prosecutor's Office.

IMPORTANT NOTE: The County Engineer has determined that an "actual physical disaster" has occurred and wishes to proceed with the necessary repairs without the process of competitive bidding, in accordance with Ohio Revised Code Section 307.86(A)(2). On July 23, 2019, duly recorded in Journal Volume 150, Page 22569, the Board of Trumbull County Commissioners adopted a Resolution declaring that a "state of emergency" exists with respect to major flooding in Kinsman Township and the resultant collapse of Lakeview Drive.

NOTE: Actual costs will be based on JET Excavating's approved rate schedule and ODOT's most recent Construction and Material Specifications Manual.
