

LEGAL NOTICE

Sealed bids for the furnishing of all labor, material, and equipment necessary for **SECURITY CAMERA EQUIPMENT/INSTALLATION AT VARIOUS LOCATIONS THROUGHOUT THE CENTRAL BUSINESS DISTRICT OF WARREN, OHIO**, in accordance with the project specifications prepared by Thomas Fok & Associates, Inc. in coordination with Trumbull County, Ohio. Bids will be received by the Board of Trumbull County Commissioners, at the office of the Board, in the County Administration Building, 5th Floor, 160 High Street N.W. Warren, Ohio 44481, until **1:00 p.m.** Warren, Ohio, time, on the **17th day of August, 2018**, and shall be opened and read on the same day thereafter.

Copies of the specifications are on file in the Office of the Board of Trumbull County Commissioners, where they may be examined or obtained at no cost.

Each bid shall contain the full name and address of each person or company submitting the same and all parties interested therein and shall be accompanied by a Bid Guaranty and Performance Bond in the sum of 100% of the amount of the bid or a certified check in the amount of 10% of the bid, payable to the Trumbull County Commissioners, as a guarantee that if the proposal is accepted, a contract will be entered into. The bond or check of all unsuccessful bidders shall be returned to them by the contracting authority immediately upon awarding the contract or rejection of all bids. All bids must be signed in ink. Facsimile or electronic transmissions are not permitted.

Contractors will have access to the project areas for the purpose of examination, measurement, and familiarization prior to bid submission. A pre-bid meeting is scheduled for Contract A included in the bid document. Contract A relates to Trumbull County Government's Camera Equipment and is a Construction Bid consisting of providing and installing a total of 16 (sixteen) safety/security cameras at the parking areas along the east side of Harmon Avenue NW; on the County Administration Building; on the Stone Building; and on the Job and Family Services Building. All 16 cameras are to be connected to the County's existing recording units. Engineered plans and material specifications are included with the bid book. The pre-bid meeting for Trumbull County's Contract A is scheduled for Friday, August 10, 2018, at 9:00 a.m. in the Trumbull County Administration Building, 5th Floor Hearing Room, Board of Trumbull County Commissioner's Office, 160 High Street NW, Warren, Ohio 44481.

Contractors are to provide their proposed material specifications/shop drawings, implied warranties, and maintenance time frames with associated costs with their bids.

NOTE: Contractors will not be compensated for generating their bid proposals.

Bids of corporations not chartered in Ohio must be accompanied by proper certifications that such Corporation is authorized to do work in the State of Ohio.

Bidders must comply with the prevailing wage rates on Public Improvements in Trumbull County, Ohio, as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614.644.2239

Attention is directed to the requirement that each proposal must be accompanied by a Non-Collusion Affidavit duly signed by the bidder, and a Personal Property Delinquent Tax Affidavit duly signed by the bidder—required by Section 5719.042 of the *Ohio Revised Code*—thereof. No payment shall be made on any Contract for which no such affidavit has been submitted.

Attention is also directed to all bidders that Trumbull County adopted a “New” Drug and Alcohol Free Workplace Policy on September 7, 2016, and the terms of this Policy also apply to any contractors directly reimbursed for services through the County; a copy of the Policy to be part of proposal, and that each proposal be accompanied by a “Sign-Off Sheet” duly signed by the bidder thereof.

Attention is also directed to all bidders that pursuant to *Ohio Revised Code* Sections 307.86 and 307.87, effective September 26, 2003, this notice of bid will be published one time only, with the condition that this notice has been posted on the County’s Internet Site on the worldwide web and found at <http://www.demandstar.com/>. (This notice may also be found on the Commissioners’ website at www.commissioners.co.trumbull.oh.us.)

The Board of Trumbull County Commissioners reserves the right to reject any or all bids submitted and to waive any informalities or irregularities in any bid received, and to determine the lowest and best bid in accordance with the methods and criteria in the bidding documents. No bids may be withdrawn for a period of at least sixty (60) days after the opening thereof.

Bids shall be submitted in a sealed envelope clearly indicating on the outside, “**SECURITY CAMERA EQUIPMENT/INSTALLATION CONTRACT A**” – as well as the name and address of the person or business submitting the proposal.
