The Trumbull County Transit Board has set a DBE goal of ten (10%) percent for the procurement.

The Transit Board reserves the right to solicit or to waive a new solicitation, for new bids if sufficient effort has not been made to comply with the DBE goals and requirements.

All bidders are certifying that they are not on the Comptroller General's list of ineligible Contractors by signing the proposal page.

A five (\$500.00) hundred dollar bid bond or cashier check is required at the time of bid submission. Bid security furnished in bond form, shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.

The Trumbull County Transit Board reserves the right to reject any and/or all proposals, to re-advertise for proposals and to waive any informality in any proposal and to determine the most responsive proposal by its own criteria, as described within the specification.

The Authority further advises prospective bidders that all bids must be filed on the forms provided and that all bids must be clearly marked on the lower left side of the outermost envelope with the words, **ATTN: RFP #2019-PTS**.
