**THE TRUMBULL COUNTY COMMISSIONERS ANNOUNCE THAT EFFECTIVE APRIL 5, 2021 AT 8:30 A.M., THE TRUMBULL COUNTY ADMINISTRATION BUILDING, LOCATED AT 160 HIGH STREET, N.W., WARREN, OHIO WILL BE OPEN FOR SERVICES WITH THE FOLLOWING PROTOCOLS:**

- **FACE COVERINGS ARE REQUIRED FOR ALL EMPLOYEES AND ANYONE ENTERING THE BUILDING—SUBJECT TO MEDICAL EXEMPTION, AND SHOULD BE WORN WITHIN THE BUILDING.**
- **SOCIAL DISTANCING SHOULD BE EXERCISED AT ALL TIMES.**
- **HAND SANITIZERS ARE AVAILABLE FOR USE ON ALL FLOORS.**
